4. WORKGROUP REPORTS

There were no written reports tabled. Members **NOTED** that wheeling arrangements were currently

too complex and costly for most corporate participants to pursue. Only three bids were received for

coal projects by DoE following their call for proposals. The insistence on 51 local equity in the projects

were a major complication. Local banks also have limited capacity to fund larger projects.

a. To compile a set of pending cases to use to stimulate NERSA to complete the wheeling

regulatory framework. SP

b. To compile a rough guideline based on case information and agreements with NERSA and

posting to the SAIPPA website to help paid up members navigate these processes. The

president to take up the matter with NERSA. SP / SG

5. STAKEHOLDER ENGAGEMENT

The chairman advised of an approach from the DRC for the association to assist IPP participants there

to form an industry body.

AGREED to encourage participants in other African countries to form local IPP bodies and to explore

areas of collaboration.
