# 1. WELCOME AND APOLOGIES

The chairman welcomed members present and noted the above apologies.

#### 2. SAWEA

Secretaries: VdW & Co

The executive officer of SAWEA then participated in a discussion on common issues between SAIPPA, SAWEA and also on the subject of the South African Renewable Energy Council (SAREC). It was noted that the integrated energy plan will be open for public comment in the near future. SAREC is considering a draft constitution. Each of the four participants will contribute an amount of R65 000 while the German industrial development agency GIZ will sponsor the remainder two thirds of operating cost. The aims of SAREC is to represent the common lobby interests of the participants with government.

# 3. FINANCIAL STATEMENTS AND MEMBERSHIP

The secretary tabled year to date financial statements, including a to-year-end projection of income which was considered and NOTED. A schedule of members indicated that all memberships were paid up. Members debated potential new member options.

#### 6. REGULATION

Members debated the status of various pieces of legislation noting that the ISMO Bill appears to have been re-directed by the council or provinces, and that the second amendment of the electricity regulatory act as well as the Regulators Bill is not clearly in the legislative process.

**AGREED** to write to the chairman of the parliamentary portfolio committee on energy to request copies of the latest versions of the second amendment to the electricity regulatory act as well as of the electricity regulators bill.

# 7. LOBBY AND REPRESENTATION

**NERSA:** Mr Long advised of ongoing problems that his clients have in obtaining generation licenses. Members noted that NERSA has requested comment from SAIPPA on the Genflex tariffs. Messrs Kuni and Mohammad are preparing comments on the Genflex tariffs on behalf of SAIPPA.

**AGREED** to approach NERSA and request a regular meeting to discuss the licencing of embedded generation as well as regulatory interpretations in this regard.
